APRIL IS SECOND CHANCE MONTH

Second Chance Month has emerged as a nationwide campaign, since its founding in 2017, to raise awareness of opportunities for the tens of millions of Americans with criminal records who have paid their debt to society.

Since it's founding 48 years ago, Dismas House has stood as a champion of second chances for men newly released from incarceration. Dismas House believes in supporting the whole man by offering a wide range of evidence-based programming that focuses on our four pillars - basic needs, health and well-being, life skills, and legal support - to help build a path to successful reentry.



"It is our love for humanity that is embodied in the daily work of Dismas House where we help men who were formerly incarcerated find renewed meaning and purpose in their lives," said CEO Kay Kretsch. "We have designed our reentry solutions to ensure that we can provide a second chance program that will change lives and reduce recidivism. Second Chance Month is the opportunity for us to identify, and show compassion and consideration for the challenges faced by returning citizens."



The Music City Chapter of Love on a Leash was founded in September 2015 and they have 26 certified handlers with a variety of dogs, cats, and even rabbits who make visits to campuses like Dismas House as well as senior living facilities, special needs classrooms, schools, hospitals, doctor's offices, and libraries in Davidson and the surrounding counties.

DISMAS MAKING LEGISLATIVE CONNECTIONS

Members of the Criminal Justice Committee were treated to a delicious breakfast from one of our Community Dinner partners, Patchwork, and Chef Ben Tyson. Legislators from all over the state of Tennessee were able to hear about the mission of Dismas House, learning first-hand from residents about the reentry challenges they face.

VIRTUAL CONNECTIONS

Dismas House CEO Kay Kretsch served as a panelist during the day-long virtual Belmont University Law School Criminal Law Journal annual Spring Symposium.

"The barriers for returning citizens around the world are not unique and is a humanitarian issue we need to address with new solutions," Kretsch said.



Joining Kretsch on the panel that examined 'Reentry Successes and Failures' were Chris Young, tech entrepreneur and advocate for returning citizens; Dorris Walker-Taylor of Thistle Farms; Larry Craig, Project Return's Social Enterprise Director; Albert Barker with Worldview Australia; and hosted by Tory Johnson.

The panel discussed affordable housing, workforce readiness, second chance employment opportunities, mental health and substance use disorder treatment options. Other topics discussed were how to best prepare returning citizens for release, ways reentry can be improved, and the role of government with reentry in both the United States and in Australia.
